[Patch Adobe ColdFusion Vulnerabilities Being Exploited in the Wild ASAP](#)

Adobe has issued alerts on three vulnerabilities affecting its ColdFusion product. The first alert, issued on July 11, 2023, announced patches for CVE-2023-29298, an improper access control issue that can lead to a security feature bypass, and CVE-2023-29300, a deserialization issue that can be exploited for arbitrary code execution. [European Commission Adopts EU-U.S. Data Privacy Framework](#)

On July 10, the European Commission (EC) published its data adequacy decision for the new EU-U.S. Data Privacy Framework (EU-U.S. DPF). This means that companies can transfer personal data from EU countries and from Iceland, Liechtenstein and Norway to U.S. organizations participating in the EU-U.S. DPF consistent with EU law. It is also expected that the adequacy decision will facilitate transfers through other EU legal mechanisms, including Standard Contractual Clauses and Binding Corporate Rules. [Read more](#)

[FAA UAS Remote ID Rule and the Insurance Industry Data Use Case](#)

As more and more unmanned aerial systems (UAS or drones) hit the skies, the Federal Aviation Administration (FAA) issued the UAS Remote Identification (RID) Rule to increase airspace safety and security. The time has come for the Rule to go into effect. As of September, the FAA's remote ID requirements take effect. This means that UAS must comply with the Rule by facilitating their identification and tracking. While this Rule was opposed by some due to the privacy concerns, the good news for the UAS aviation industry is that it can now take advantage of the RID data that will follow. The industry can monitor pilot operating habits, use the data to investigate UAS incidents and even use the data to offer more tailored, personalized services using drones. [Read more](#)
